Rehabilitation of obstetric fistula survivors, and support for reintegration back into their families and communities to be productive contributors both as community ambassadors for safe motherhood and to help their families thrive. The holistic Safe Motherhood Ambassador™ Training program, with training centers in the Amhara, Tigray, Southern, Sidama and Oromia regions of Ethiopia, provides spiritual, physical, emotional, and economic support.

Prevention activities promote safe childbirth practices and grow awareness of obstetric fistula, through pregnant women conferences, religious and community leader training, marketplace, and school awareness programs.

Identification of hidden or any cases of existing obstetric fistula is the third pillar; activities include training health professionals in diagnosis, treatment and referral pathways and SMA work to find and bring in suffering women for diagnosis and treatment.

To date, we have trained over 3,500 Safe Motherhood Ambassadors and supported the safe delivery of 28,000 babies.
